He has stated that pursuant to the provisions of section 233 of the Companies Act, 2013, the scheme of merger or amalgamation of Shiva Profiles Private Limited (Transferor Company registered in NCT of Delhi) with Frog Cellsat Limited (Transferee Company registered in NCT of Delhi) has been approved by their respective members and creditors as required under section 233 (1) (b) and (d) of the Companies Act, 2013 (herein after referred as the Act). He has confirmed compliance of procedure as laid down under the Companies Act, 2013 and Rules made thereunder. Further he has stated that Appointed Date of the scheme is 01.04.2021. Lastly, he stated that Registrar of Companies, N.C.T of Delhi has reported certain observations vide his report dated 03.08.2022 which were taken up and on perusal of the reply of the Company it is found satisfactory. The Official Liquidator has also furnished /given their reports and have no objection in the scheme subject to compliance of provisions of the Companies Act, 2013.



Accordingly, the scheme is confirmed subject to compliance of section 233(11) of the Act and the condition that any part of the scheme if in contravention of this Companies Act, 2013 shall be null & void in terms of provision of section 6 of the Act and further condition that the other Authorities retain their recourse of recovery in respect of any existing or future tax liabilities/claims of the Transferor Company from the Transferee Company.
